Creativity	10 points

INFORMATION AND RULES:

1. Open to any individual who is a Pennsylvania resident; one entry per person.
2. Entry to be a pie that must include at least 60% apples in the filling. It does not need to be a "traditional" two crusted apple pie. Judges are looking for a variety of fillings. Creativity is encouraged and is essential to a varied competition.
3. The entire pie must be submitted for judging in a disposable pie pan.
4. Recipe must be submitted with the entry for the pie and pie crust. Neatly handwritten or typed on one side of 8 1/2" x 11" paper. Recipe must list all ingredients, quantities, and the preparation instructions. Entrant's name, address and phone number must be printed on the back side of the pages.
5. Refrigeration is not available at the Fair or PA Farm Show. Entries that require refrigeration after baking must indicate so in the recipe. Those entries will not be sold, auctioned or otherwise distributed for consumption after judging for food safety reasons.
6. Judging will be based on the following criteria:

Flavor	30 points
Filling: consistency, doneness, moistness, & flavor	25 points
Crust: color, flavor, texture, doneness	20 points
Overall Appearance	15 points
Creativity	10 points

7. Recipe(s) listing all the ingredients and the preparation instructions must be submitted with the entry (*printed on one-side of 8-1/2" x 11" size paper*). Entrant's name, address and phone number must be printed on the back of the page.
8. Judging will be based on the following criteria:

Flavor (smell, taste, flavoring)	30 points
Inside Characteristics (texture & lightness)	25 points
Overall Appearance (surface, size, color)	20 points
Creativity	15 points
Topping, Icing or Decoration	10 points
